In accordance with the requirements of the constitution by-law no 6
“The selection of judges” the following shall apply:

- a) Three judges shall be selected from 3 star and above members present at a club meeting to do the judging.
- b) Visiting judges may judge singly, in pairs or threes. They may also choose to use the matrix.
- c) In case where a judge has submitted photo`s, he/she will not give a point for scoring but the other two judges scores will be halved and then added to the two judges score for a total score. If the score, when halved is ending on half a point the score of next full score will be added. i.e 2 and half - add 3 (next full score)

CLUB BY - LAW NO. 7 DATED

In accordance with the requirements of the constitution by-law no 7
“Club Trophy Night” the following shall apply:

- A) The Club Trophy Night shall be held on the first Tuesday of August of each year.
- B) Judging to be restricted to trophy awards of photo's of the current year. 1 July to 30 June.
- C) Trophy Night entries are restricted to all fully pay members.
- D) The author must have entered his work for judging, committee decision, during the trophy year, which runs from 1 July - 30 June the following year.
- E) An author may have three entries per category, but not more than ten pictures in total.
- F) Trophy night must be judged by three judges, preferably visiting judges, using a five point electric scoring box.

The following floating trophies are to be contested:

- 1) Luiz Antunes Floating trophy for Photographer of the year based on the accumulated points as per Bylaw 2 for the year.
- 2) Wessel Meyer Floating trophy for best progress for the year (Junior - 1 to 3 star) based on the accumulated points as per Bylaw 2 for the year.

- 3) Gerald Green Trust floating trophy for most set subject monthly winning entries for the year.
- 4) Category winners based on the accumulated points scored in each category for the year.
